Producers now have more time to repay Farm Service Agency Marketing Assistance Loans. The loans now mature at 12 months rather than 9. This flexibility is available for most commodities.

Certified organic operations can receive up to 75% of their certification costs paid during the program year, not to exceed \$750 per certification scope.
