## **NOP Priorities Listening Session & NOP Proposed Rule: Amendments to the National List of Allowed and Prohibited Substances (Crops and Handling)**

Dear PCO Certified Operators, Members, and Inspectors,

The National Organic Program (NOP) has announced a public listening session and a proposed rule, both of which offer opportunities to comment directly to the program.

### **NOP Priorities Listening Session**

The NOP has announced a public listening session, with request for comment, regarding upcoming standards development activities. Specifically, the NOP is looking for comments and feedback to prioritize rulemaking. Examples of appropriate comment topics include outstanding National Organic Standards Board recommendations, such as:

- Organic Apiculture Production Standards
- Organic Pet Food Product Standards
- Organic Mushroom Production Standards
- Organic Aquaculture Production Standards
- Hydroponic/Aeroponic Production and Greenhouse and Container Production Standards
- Clarification of Emergency Synthetic Parasiticide Use with Organic Livestock
- Eliminate Incentive to Convert Native Ecosystems to Organic Production
- Establish Standard Criteria for Commercial Availability Determinations—Agricultural Ingredients in Processed Products Standards
- Require Increased Use of Organic Seed
- Recommendations Related to Genetic Engineering and Excluded Methods
- Organic Personal Care Product Standards
- Restrict the Use of Livestock Vaccines Made from Excluded Methods

The NOP will not be accepting comments on current rulemaking priorities, which include Strengthening Organic Enforcement (SOE) Final Rule, Origin of Livestock (OOL) Final Rule, Organic Livestock and Poultry Standards (OLPS), and Inert Ingredients in Pesticides for Organic Production.

**Instructions for Giving Public Comment** – sign up for oral comments by February 28, 2022. Written comments due March 30, 2022.

The NOP wants to hear directly from organic producers and handlers on your rulemaking priorities! Sign up for oral comments by February 28, 2022. Submit your written public comments by 11:59PM EST March 30, 2022. ## **NOP Proposed Rule: Amendments to the National List of Allowed and Prohibited Substances (Crops and Handling)**

The NOP has published a proposed rule that would amend the organic regulations at §§205.600-205.606, The National List of Allowed and Prohibited Substances (the National List). The comment period for this draft rule is now open; comments will be accepted until April 4, 2022. This proposed rule would:

- Allow **paper** for use as a planting aid in organic crop production
- Allow **low-acyl gellan gum** for use as a thickener, gelling agent, or stabilizer in organic food processing.
- Correct a spelling error on the National List to change “wood resin” to “wood rosin.”

### **Crops**

The proposed rule amends § 205.2 by adding, in alphabetical order, the definition for “Paper-based crop planting aid”:

*Paper-based crop planting aid.* A material that is comprised of at least 60% cellulose-based fiber by weight, including, but not limited to, pots, seed tape, and collars that are placed in or on the soil and later incorporated into the soil, excluding biodegradable mulch film. Up to 40% of the ingredients can be nonsynthetic, other permitted synthetic ingredients at § 205.601(j), or synthetic strengthening fibers, adhesives, or resins. Contains no less than 80% biobased content as verified by a qualified third-party assessment (e.g., laboratory test using ASTM D6866 or

composition review by qualified personnel). Added nutrients must comply with §§ 205.105, 205.203, and 205.206.

The proposed rule also amends § 205.601 by revising paragraph (o) to read as follows:

§ 205.601 Synthetic substances allowed for use in organic crop production...

(o) Production aids:

...

(2) Paper-based crop planting aids as defined in § 205.2. Virgin or recycled paper without glossy paper or colored inks.

### **Handling**

The proposed rule amends § 205.605 by revising the entry for “Waxes” in paragraph (a):

§ 205.605 Nonagricultural (nonorganic) substances allowed as ingredients in or on processed products labeled as “organic” or “made with organic (specified ingredients or food group(s)).”

(a) ... Waxes—nonsynthetic (Wood rosin).

The proposed rule also amends § 205.605 by adding, in alphabetical order, an entry for “Low-acyl gellan gum” in paragraph (b):

§ 205.605 Nonagricultural (nonorganic) substances allowed as ingredients in or on processed products labeled as “organic” or “made with organic (specified ingredients or food group(s)).”

(a) ... Low-acyl gellan gum
