Please discard the previous Grass-fed Materials list!

The UPDATED 2019 PCO Approved GRASS-FED Materials List includes feed additives/supplements that PCO has reviewed and approved under the National Organic Program (NOP) regulations and for our GRASS-FED producers. The materials allowed under the new Organic Plus Trust (OPT) Certified Grass-fed Organic Livestock standards have changed significantly since our last list, so please discard that list and work only from this list for the remainder of 2019.

This list includes two tables:

Table 1 includes supplements that are currently allowed and will continue to be allowed under the new Organic Plus Trust (OPT) Certified Grass-fed Organic Livestock standards.

Table 2 includes supplements that are currently allowed but that **WILL BE PROHIBITED** under the new OPT Certified Grass-fed Organic Livestock standards. The materials in this table can be used during 2019 but use must be discontinued on or before December 31, 2019. Please note that medical treatments permitted for use on organic operations are also permitted for use on PCO 100% Grassfed operations and OPT Grass-fed operations. Applicable restrictions must be followed.

If you are interested in using a material on this list, make sure you are using the exact brand name and formulation listed here. When in doubt, contact PCO! It is YOUR responsibility to ensure that any material you use is allowed under the NOP regulations and the PCO 100% Grass-fed standards OR the OPT Certified Grass-fed Organic Livestock standards. Contact PCO if you are interested in using any material not included on the PCO Approved Materials List. Using a material without prior approval from PCO may jeopardize your certification status! All materials used or intended to be used, must be listed on your Materials Used Form.

WHAT IS ALLOWED FOR OPT GRASS-FED?

Please remember that you can use up your currently allowed products until the end of 2019. Use of any products that are not approved under the below criteria must be discontinued on or before Dec. 31, 2019.

Weaned animals may be fed:

 Grazed and harvested forages comprised of annual and perennial grasses, legumes, forbs, brassicas, and browse; and

- Grazed and harvested vegetative-stage cereal grain plants (corn in a pre-tassel stage, soybeans prior to bloom; small and cereal grains pre-boot stage)
- Stored forage in cube or pellet form, provided that it is not be fed over a daily limit of 0.5% of an animal's body weight
- Forage grown in fodder sprout systems, provded that it is limited to 1.75% of an animal's body weight and not more that 20 lbs. per day; that the sprout roots are removed prior to feed; and that it is fed solely during the non-grazing season
- Certified organic sugar cane molasses, certified organic sugar cane dry sugar, certified organic whole sugar beets, certified organic sugar beet pulp, certified organic carrot pulp, certified organic citrus pulp, and certified organic alfalfa pellets, provided that these products are not fed above set combined daily limits on a dry matter basis:

- Certified organic kelp
- Certified organic vinegar has been informally clarified to be allowed by OPT.
- All agricultural ingredients not listed above as allowed will be prohibited in 2020, unless current
 OPT standards are changed. This includes but is not limited to herbs, yucca, alfalfa meal, sunflower
 meal, etc. Remember, you can still use the organic versions of these products in 2019, but you
 must discontinue use by Dec. 31, 2019. If you would like to see these or other prohibited materials

- Vitamins and minerals, as approved for organic use at 205.603(d). Vitamin and mineral mixes can contain
 agricultural ingredients listed above as approved, as well as grain and grain-byproduct carriers, provided
 that livestock do not consume more than 8 ounces of grain or grain-derived carrier per animal in a twentyfour hour period, or no more than 16 ounces of the complete product (assuming 50% carrier, unless
 otherwise specified) per animal in a twenty-four hour period.
- Non-agricultural non-synthetic ingredients not prohibited at 205.604, such as yeast

Pre-weaned animals may be fed:

milk only

All allowed agricultural products, including pasture and forage, must be certified organic.

RESTRICTIONS

Restrictions for brand name materials are indicated as applicable throughout this list. The name of the restriction will be listed in the right side column. Use of the material must comply with the full and complete text of the restriction, as listed in this section.

PCO 100% Grass-fed Standards restrictions (only apply to operations certified to this program in 2019):

Organic Grain or Grain By-Products. Organic grain or grain by-products used as carriers within a vitamin or mineral supplement for grass-fed livestock are allowed, provided that: Must be fed at labeled rates or does not exceed a rate within the normal range of consumption as prescribed by the manufacturer, a veterinarian, or qualified nutritionist; and must not be used with the intent of utilizing it as a grain supplement. 2.3.4(a) and (b)

Organic Plus Trust (OPT) Certified Grass-fed Organic Livestock Standard restrictions (only apply to operations certified to this program in 2020):

OPT: Restricted Feedstuff. Feed additive or supplement must not be fed above the combined daily limit on a dry matter basis (sugar cane molasses, 4 lbs.; sugar cane dry sugar, 4 lbs.; whole sugar beets, 5 lbs.; sugar beet pulp, 5 lbs.; carrot pulp, 5 lbs.; citrus pulp, 5 lbs.; and alfalfa pellets, 5 lbs.). *OPT V.E.*

OPT: Grain and Grain-derived Carriers. Livestock must not consume more than 8 ounces of grain or grain-derived carrier per animal in a twenty-four hour period, or no more than (16 ounces) of the complete product (assuming 50% carrier, unless otherwise specified) per animal in a twenty-four hour period. Must not be used to circumvent the prohibition on the use of grain in the certified animal's diet. *OPT Memo No.* 006
